



Jefferson City Beautification & Tree Board Beautification Awards Program

What is the award?

The Beautification & Tree Board of Jefferson City sponsors the Beautification Awards. The recognition is awarded in April (spring season) and October (fall season), following a rigorous judging of nominated properties. Award nominees are divided into three categories: residential, commercial and non-profit organizations. Winners are awarded a certificate of accreditation, an acknowledgement sign to be placed on the site temporarily and a photo of the site will appear on the City social media platforms. Winners will also be publicly recognized at the appropriate meeting of the Jefferson City Council. Other prizes may be added.

Purpose of the award:

- To encourage environmental stewardship, health and appearance, to further the goals of making Jefferson City a better place to live, work and play.
- To encourage sustainable efforts; support acceptable design maintenance and promote inspiration in neighborhoods.
- To recognize citizens and businesses who are making a positive difference in our community.

Who is eligible?

Any residential, commercial, business or public property (including government buildings) within the city limits of Jefferson City may be nominated. The “public” areas of apartment complexes, condominiums, townhome developments, residential subdivisions, schools, hospitals and churches may be nominated. Previous winners are not eligible for a period of five years.
